
The National Institute of Cancer Prevention and Research, Noida wishes to invite the rates/ quotations for the items mentioned in the attachment.

You are requested to submit your quotation as per the following terms & conditions:-

Terms & Conditions:

1. Quotation for the requisite items (list attached), addressed to the "Director, ICMR-National Institute of Cancer Prevention and Research, I-7, Sector-39, Noida" should be submitted to Stores-In-Charge, Stores Section, NICPR, NOIDA, **latest by 04.02.2023 till 5 PM.**
2. Only sealed quotation will be considered.
3. Kindly mention the subject **"SK –Transcriptome Analysis"** & [due date], on the top of envelope.
4. **Quotation received after the last date and time or not in attached format is liable to be rejected.**
5. **Name of items should be provided in format of quotation instead of mentioning "item-1", "item-2", etc.**
6. **Quoted Items should be readily available with the vendor.**
7. **Quotation should have a minimum validity of 03 Months.**
8. Quotation should have the file reference number as mentioned above.
9. The quotation is to be submitted only in the format enclosed. Not acceptable in any other form.
10. **Price should be quoted on the Vender's Letter Head, duly stamped and signed.**
11. In the quotation, Sl. No. and name of the items should be same as per the format enclosed.
12. It is mandatory to indicate the GST number in Quotation as well as in the bill for our information.
13. GST will be applicable as per GoI norms to ICMR-NICPR, Noida. Rates may be quoted with GST@5% against the GST/DSIR Certificate.
14. Quotation should be preferably, typewritten and every correction in the quotation should invariably be signed by the bidder, failing which, the quotation is liable to be rejected.
15. The bidder conditions mentioned in the quotation shall not be binding on ICMR-NICPR, Noida.
16. Vendors may be asked to provide sample of goods/reagents/plastic ware/kits for quality/compatibility before accepting the order. In case the goods are not in conformity with the quality, the order shall stand cancelled.
17. Any dispute concerning any Terms and Conditions of the Quotation and/ or the supply of items, will be subject to Delhi Jurisdiction only.

18. Materials should be delivered within **Four Weeks** at ICMR-NICPR, Noida from the date of issue of purchase order. The liquidated charges @ 0.5% per week shall be imposed if supply made after expiry of delivery period subject to maximum 10% of the total value of goods/ contract value.
19. If, in the price structure quoted by a bidder, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly. If there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail.

Details:-

1. **RNA extraction and quality assessment:**
 - a. Should perform total RNA extraction (cell-free + exosomal). Sample - human plasma.
 - b. Should perform RNA quality checks (using Tape station/ Bioanalyzer)
2. **Library preparation and sequencing:**
 - a. Should perform Long non-coding RNA (lncRNA) library preparation (including Ribodepletion)
 - b. Should perform sequencing on Illumina Nextseq 2000 platform or higher using 150*2 chemistry, 80-100 million reads per sample.
3. **Bioinformatics analysis:**
 - a. Should perform downstream data analysis: Raw data QC and report, alignment to reference genome, transcript identification, differentially expressed genes (DEGs), p-value significance of gene list, annotations, GO analysis, KEGG pathway analysis, Heat map and clustering, Venn diagram.
 - b. Should submit Fast QC report for the sequencing output.
4. Should provide gel images regarding RNA quality, library validation checks, raw sequencing data, etc.
5. The firm should have prior experience/ record (4-5 years minimum) in Whole transcriptome sequencing/ NGS projects and testimonials for the same should be provided.
6. Samples (tissue, RNA, etc.) must not be sent out of India.
7. Should provide proof of lab facility. Partner/ collaborator company lab certificates located in India/ abroad will not be considered.
8. The progress details should be intimated to the user scientist, and in case of any issues further processing will be based on the user scientist's instructions.
9. Data should be delivered through a secured server and HDD only. Data should not be written on CDs/ DVDs.
10. The firm should not be blacklisted/ debarred or banned by any government department/ public sector undertaking.
